Drum Demands

People have asked, Chrysler Corp. has been seeking, and the black workers have sometimes been confused about the direction of D.R.U.M. The editorial staff of D.R.U.M. has communicated with the black workers and their demands have been compiled. It should be understood by the readers that the voice of black unity must be heard, and its results are inevitable.

D.R.U.M. was formed not only to put an end to racism at Hamtramck Assembly, but also to extend our fight to the entire Chrysler Corp., General Motors, Fords, and wherever racism exists. D.R.U.M. was founded by black workers from the grass roots. From the enthusiastic response from the brothers at the plant, we know that our voice has been heard, and our position accepted by many. Before peace and tranquility can prevail, our demands must be met and our goals achieved, by any means necessary.

Time like nature is an ever changing progression for man. And here in 1968, Chrysler Corp. is still practicing 18th century slavery. This is why D.R.U.M. must list and have its demands met now.

DEMANDS

1. D.R.U.M. demands 50 black foremen

2. D.R.U.M. demands 10 black general foremen immediately

3. D.R.U.M. demands 3 black superintendents

4. D.R.U.M. demands a black plant manager

D.R.U.M. demands that the majority of the employment office personnel be black

5. D.R.U.M. demands all black doctors and 50% black nurses in the medical centers at this plant

6. D.R.U.M. demands that the medical policy at this plant be changed entirely

7. D.R.U.M. demands that 50% of all plant protection guards be black, and that every time a black worker is removed from plant premises that he be lead by a black brother.

8. D.R.U.M. demands that all black workers immediately stop paying union dues.

9. D.R.U.M. demands that the two hours pay that goes into union dues be levied to the black community to aid in self determination for black people.

10. D.R.U.M. demands that the double standard be eliminated

and that a committee of the black

rank and file be set up to investigate all grievances against the corp., to find out what type of discipline is to be taken against corporation, and also to find out what type of discipline is to be taken against Chrysler Corp. employees.

11. D.R.U.M. demands that all black workers who have been fired on trumped up racist charges be brought back with all lost pay.

12. D.R.U.M. demands that our fellow black brothers in South Africa working for Chrysler Corp. and its subsidiaries, be payed at an equal scale as white racists co-workers.

13. D.R.U.M. also demands that a black brother be appointed as head of the board of directors of Chrysler Corp.

The power base for these demands will be as follows:

1. Legal demonstration at Local 3 and Solidarity house.

2. Legal demonstration at Highland Park (Chrysler Corp. headquarters)

3. Legal shut down of Hamtramck assembly.

It should be understood that these tactics will take place before July 19, 1968 and will be supported by the entire black community. The white power structure must also understand that

Chevrolet

Yes, you black workers of General Motors, Stop, Look and Listen. We black brothers realize we are being exploited by the ex-slave owners children. Something must be done. These pigs not only exploit our brothers here in the united states, but they also help exploit us as far East as South Africa.

To be specific; Chevrolet Gear & Axle displayed a typical example of individual racism. Recently a black soul brother was injured in a slave camp. The brother's finger was cut severely and he was sent to first aid to receive medical attention. After being damaged by these unqualified white rats, pigs he was struck to his job. Without refusal, he worked the rest of the night with one hand, only because he did not acquire his right hand. The following day the brother consulted his family doctor, received proper medical attention and was told to refrain from using his hand. Two days later the brother received a western union from Chevrolet stating, an I quote; "Please be advised that you have been released as an unsatisfactory ten hour employee due to absenteeism."

Upon receiving the letter the brother went to the plant to find out the real deal. After entering the office of plant two he was greeted by a white clerk. He then stated who he was and his business there, and asked to see

the committee men. The brother didn't have ninety days in so he refused to call the committee men. Then the brother asked to speak to the plant superintendent. After waiting for some time the superintendent came on the scene. When the brother tried to talk with him man to man instead of black boy to white superman he could not accept this. He opened the door to the lobby and called

the klu-klux-klan (plant protection) and said, quote: "throw this guy out of here." Not until then did the brother show his true color- Black Black Black a matter of minutes, ten or fifteen klu-klux-klan men were there. Being a real soul brother he would not take the pushing around from the klansmen so he struck back. He defended himself equally as violently as they attacked. Soon many black brothers had gathered and wanted to know what was happening. Then and only then the white faggots realized no one was Bullshitting and decided to get back. This is only one display of these racist pigs' methods. This particular company has exploited and oppressed black men and women for decades.


Now black brothers we must unite and destroy this racist system by any means necessary. One way is to stand up and be counted as Black Men, not as boys, toms, or puppets.
