

## LILY WHITE-SUPER RIGHT

LILY WHITE, SUPER RIGHT INJUST ICE against BLACKS

Prejudice, racism, favoritism, chaos and confusion; all of the things that Chrysler ist against was supported by them Thursday, May 8, 1969. There was a hillbilly, razor back who referred to a black brother as a "nigger". This was said to Brother John who works as an inspector in dept. 3200, 6th floor, big line. Bro. John got the steward and the tom ass labor relations man, Young, on the case. After the wet back Chuck saw that Bro John was going to take action he then apologized. He said he was sorry in front of the house nigger and the UAW toms. This was enough for management: the labor relations house nigger Young, said that there was nothing, that he could do after the hill -billy had said he was sorry. Young said that Bro John should be a big man because this was something that he would have toThis hillbilly disrespected all black men's manhood and showed no respect for Bro John as amman, but as a nigger (which is nothing; a nigger is something neutral which cannot function, under its own power; a nigger has no brains, the white man thinks for him completely). This is discrimination and prejudice coming from the hillbilly. And Chrysler stood by and allowed this to happen.

8 How long are we as black men going to allow this to happen? We must take a stand against this type of thing. This type of racism is all over this plant, all departments. Chrysler knows it and yet it is happening because 95% of all foreman are hillbilly slavedrivers. Hillbilly George Harpers knows this type of thing happen and does nothing about it and this is one of the reasons it is still happening. The other reason is that we, as black men

don't take the stand that we should against this practice and the honkie. We have suffer -ed this type of infliction too long. We must kill the lily ; white system and all their setups. Black people must retaliate against the system to gain our place in the white man's world. It is time for us to get up off our knees begging. Our people have never got any place begging; our progre ss this far has come about by our bucking the honkie's system, breaking his white rules' and doing things from a black side instead of the white way. This is the only way we will continue to progress.

The next time it will be kick in the ass and all the hon-kie will have to say is "I'm sorry". And he will have label -ed you a jackass. Now take what happened in reverse: the brother would have been called a militant, a trouble maker, anything but a man. This is why the honkie said this because he knew that nothing would be done about it and he would still be called a white man.

Brothers and sisters, we have a name too and it is not "Negro" or "nigger". It is not only a name but it identifies us as a race of people, just as white identifies the honkie and pigs as a race. We must demand the respect to be recognized as BLACK men and women, not by gal, nigger men and nigger women. Until we take a stand and fight against this type of racism, against Chrysler and other racist pigs, it

will never end. 'We must fight by any means necessary and any ways available. We will no longer be harassed with the honkie's ignorance and stupid - ity, but most of all his dumb ass ways.

Join DRUM and fight against racism, exploitation, verbal
embarrassment, undo harassment,

All of us are ware of the condition that exists in these auto plants. We as black. workers are already super-exploited (given the hardest jobs and extract the fewest benefits from our labor) - An for one of our brothers to have to listen to obscenities from a white racist supervisor had the affect of fanhing the flames of indig-

### NO WHERE TO SLEEP


NC WHERE TO SLEEF/NO WHERE TO PARK YOUR CAR...HUBER SALT MINES (huber & Winfield Foundries)



#### SUPPORT BROKEN!

CALLING SUFFORT FOR BRO. KEN COCKREL

On Monday, May 26 -next Monday- The racist decadent and inhumane court in the city of Detroit shall attempt to find our revolutionary Black Brother, attorney and legal advisor for D.R.U.M., The League of Revolutionary Black Workers and freedom fighters everywhere in contempt of court. It is our duty to understand that everytime we as black workers attempt to right any of the many wrongs done to us hour-by-hour . and day-to-day in the factories of this so-called nation, that the companies respond by runnin to the courts getting judges who work in their interest to issue injunctions, restraining orders and such, to keep us, from obtaining justice. They do this even though they know that the courts are not the source of our grievance, it is the companies themselves . Therefore we must understand, that the courts are being used as obstructions to justice and not as administers of it. When black workers struck Dodge Main last July, Chrysler Corp., instead of meeting our demands went and got an injunction against us. At the hearing at

Circuit Court it was brother Ken Cockrel, who argued in behalf of black workers. It was brother Ken Cockrel who took up our defense. It was Bro. Ken Cockrel who argued so well in defense of black workers that the injunction had to be amended by the issuing judge -Judge Benjamin Burdick. It was Bro. Ken Cockrel who defended black workers, he alone who faced the entire Chrysler Corp, and its gigantic staff of lawyers along with City of Hamtramck official and UAW stool pigeons. packed court room of rich white bureaucrats and four black work -ers it was only Bro. Ken Cockrel who spoke in our behalf.

After the beatings, macings and false arrests made upon Black workers at Dodge Main, at Hamtramck Assembly Flant on Sept. 26, 1963, during the trustee election, once again Bro. Ken Cockrel took up our mantel It was Ken alone who came to Bro Ronald Brewers aid who was arrested behind the bar. It was Ken who marched into the Hamtramck Court in the middle of the trial and fought for the rights of Black workers. In a court room full of Hamtramek policemen and police commisioners, Dro Ken alone who won one case and obtained a fine in the

'nation among our black brothers; It must have taken unbelievable amounts of patience and selfcontrol to keep our, black brother from striking out in outrage at his supervisor. In respense to his obscene discharge on Thursday, April 24, the black workers struck the Ford Assembly Plant in Mahwah. Our brothers are supposed to be represented by Local 906, of the UAW. Local 906 has not had a representative union meeting in over a year. The local leadership is lily white even though. the 1.700 or 40% of the 4,200 workers are black. There is only one black committeeman, and 3 black skilled tradesman. The United Black Drothers have been in existence for about 3 months now. It was spauned out of the daily abuse, which the white racist management heaps upon black workers. The U.B.B. leveled documented charges of racism against the Management at Ford's and the U.A.W. officials, because of this they were openly attacked by the Regional Director of District 9 of the U.A.W. who stated than the charges of racism were unfounded. The U.A.W. acted true to form once again.

The U.B.B. has valiantly stood firm in its resolve to end racism and it is the duty of every other black worker everywhere to look up and meet their beck & call. The demands which were issued by the U.B.B. are very similar to the demands made by D.R.U.M. in July of last year. Their demands are:

1. The dismissal or transfer of supervisors with records of

repeated acts of discrimination

- 2. The reinstatement of workers who were provoked into violation of company rules by supervisors and were subsequently
  fired.
- 3. In view of the number of black workers employed, with related problems, we demand, more black representation in the labor relations and hourly personnel departments.

4. Establishment of the United Black Brothers as spokesmen of black workers in Mahwah.

- 5. If management has not met the above demands by April 29 1969, we shall begin the second phase of direct action, and will not be held responsible for any actions taken against the oppressive and racial policies of the Ford Motor Company.

  6. We demand no reprisals against any workers for acts taken in this fight for our human rights and dignity.
- 7. No loss of pay or privilege by any workers as a result of actions taken to win the above demands.
- 8. We as workers will defend our human rights, at any cost.

Without a doubt, we must fight side by side with the U-nited Black Brothers for their struggle is also ours.

fail, fight again, fail again fight on to victory.

Long live the Black workers at Mahwah Ford's. Long live the U.M.B. Glory to their struggle.
