#### DENOUNCE COMRADES SUPREME COURT!

# **VICTORY** EDMONTON!



Susan Herzog fights back staunchly after attack by U.S. lackey police at Congress of Labour Traitors on May 22nd, Susan was later "tried" and "convicted of assaulting a police officer".

Comrade Susan fights once more with the lackey police. After three months of persecution on the trumped up charges of "defamatory libel" which were aimed at preventing her from organizing politically, the police are denying Comrade Susan the right to speak and denounce the court for its atrocity.

Four comrades in Edmonton have won significant victory against the fascist courts, forcing them to enter a "stay in proceedings" on trumped up charges of "defamatory libel" laid down after the publication of a local newspaper "The Progressive Workers' Journal". A full summary of the history of the case appears below:

May 22nd: Comrades Susan Herzog, Re ger Tentry and Ian Walker courageous ly demonstrated against the Canadian Labour Congress conference, denouncing the CLC as the headquarters of pro-imperialist betraval of the working class. Only the night before, the Chairman of this class-collaborationist conference had given comfort and aid to fascism and the Canadian Compradores by a rabid anti-communist attack stinking of Mc-Carthyism and fascism. The two comrades carried pickets denouncing the conference and cheering the Communist Party of Canada (Marxist-Leninist). The CLC hacks were deeply shocked and frightened and tried to attack the young communists. For forty-five minutes, the communists waged tit-for-tat struggle with the hacks, exposing them on every point Then the communists were attacked by a flimsy band of fascists who had been en-couraged to show their faces by the anticommunist ravings of CLC leader McDo-

nald the preceding night. Defending themselves staunchly against this attack the comrades were further attacked by the U.S. lackey Edmonton City Police and fought back valiantly (see photo). May 24th: After having been held unjustifiably for two days in the fascist jails, where the police were wearing swastika armbands, the comrades were brought before the courts. They refused to plead to the trumped-up charges on the grounds that they are political prisoners. Their trial was remanded. Comrade Susan was denied bail altogether and held in custody. She staged a week-long hunger

strike in protest. June 29th: An issue of the PROGRESS-IVE WORKERS' JOURNAL said: "..... the "crown" prosecutor and flunkey Ma-gistrate Coughlin have refused to "authorize" the CBC to release their news-film of the demonstration..." during which the comrades were arrested. The shameless magistrate said that the comrades had to "prove to him that he had leagl authority" to release the film bese "he didn't know all the regulations" and that the workers were "incompetent to do this because they had no law degrees". He said that they should get a "defense lawyer" who would know and

Comrade Robert A. Cruise, the heroic leading spokesman of the Communist Party of Canada (Marxist-Leninist), after 44 days of hunger strike, was once again dragged before the courts of the Canadian compradores on the trumped up charge of "possessing a weapon offensive to public order". Com-rade Cruise is being viciously persecuted because he took a shotgun to Hamilton to defend a progressive bookstore against attacks by a handful of Hitlerite thugs led by the Hamilton gentry and aided by the Ham-

. Unjustifiably convicted on one charge of "assaulting police", Comrade Cruise had another charge dropped. On the one remaining charge of "possession of an offensive weapon", fearful of self-exposure, the courts are stalling in a miserable attempt to murder and stlence him. Comrade Cruise has never flinched it december the court for their rescentions of orticities. in denouncing the courts for their persecution of antiimperialist fighters. As a result he has been sen-tenced three times for "contempt of court". He has owed to continue his hunger strike until he is released or until he dies in the compradore jails. last several days he has been held in hospital in an attempt by the compradores and their lackies to conceal their true aims. At first he was chained to the

hospital bed. However, he has persisted in his revolutionary work and daily engages in discussion with progressive hospital workers

After two months of stalling, the court shameless-ly refused to proceed. It put forward the sham of a "preliminary hearing" and bound over for an indefi-nite period the date of the "trial", even though Comrade Bob has appeared in court on at least seven dif-

follow the arbitrary rules of the court. July 8th: Fascist police raided the home of Susan Herzog and arrested Fred Her zog (Susan's husband) and Ian Walker for "defamatory libel" allegedly appearing in PROGRESSIVE WORKERS' JOUR-NAL No. 4. Fred was visiting his wife at the time

July 9th: Fred and Ian came before the magistrate to "elect" the type of "trial" they would have. Both were denied bail. July 10th: Ian and Roger appeared on the CLC charges and chose "trial" by magistrate. They refused to agree with the magistrates' overruling of their choice and for this each was given 28

days for "contempt of court".

July 15th: Fred, Ian, Roger and Susan were remanded to August 5th for preliminary hearing. Bail was set at \$25,000 for Fred and \$5,000 for Ian. A fight erupted in the court as the comrades defended themselves from a frenzied attack by police agents when Fred complained that lies were being concocted about his immigration status.

July 28th: Susan was "tried" and sentenced without benefit of being able to attend her own trial. The fascist section 557 of the Criminal Code was used to deny her the right to speak in her own defense because she dared to denounce the judge and the fascist proceedings. She was sentenced to 60 days in jail for 'assaulting a police officer" fact assaulted her. Roger was senten-ced to 30 days for "causing a disturb.-

August 5th: The "preliminary hearing" on the charges of "defamatory libel" was held. "Evidence" introduced photographs of revolutionary leaders Chairman Mao and Lin Piao, along with the works of Marx, Engels, Lenin, Stalin and Mao Tsetung This "proved" that the "accu-sed" were "communists". Magistrate Rolf said that there was basis not only for charges of "defamatory'libel" but also for "sedition". "Trial" by judge and jury was set for August 31st. Comrade Fred pledged that he would persist in telling the truth even if it meant twelve years in jail. He referred to a famous quotation of Chairman Mao Tsetung to show that the reactionary courts were only "lifting a rock to drop it on their own feet".

September 8th: The four comrades appeared in court once more to "enter a plea". Fred Herzog made a statement in spite of the attempts of the prosecutor to stop him by threatening to charge him with "contempt of court". Fred said he had no association with PRO-GRESSIVE WORKERS' JOURNAL. He said: "In the true character of imperialist justice, I have been detained now for two months on only the evidence of my support for the anti-imperialist struggle, as it is quite clear from my preliminary trial." The prosecutor in-terrupted to try to suggest that Comrade Fred was insane. In a clear attempt to hide the true nature of the case, he suggested that Section 524 of the criminal code be used to "prove" Fred's "insanity" and refuse him the right to a trial. Fred staunchly went on: "To show the "innocence" of the U.S. lackey police who attacked the people demonstrating against the treacherous imperialist labour aristocrats of the CLC, your kangaroo court went so far as to spring a trial on one day's notice and then remove one of the "accused" from the courtroom during her entire trial. The court then launches an attack on an anti-imperialist journal for boldly stating the truth - that the courts do not seek truth to serve the peo ple but camouflage truth to serve imperialism." He concluded his statement by expressing complete faith in the success of the anti-imperialist revolution of the Canadian people and calling for the destruction of the U.S. lackey police

During the time that they were held

in iail, the comrades were denied the right to read any progressive literature. PEOPLE'S CANADA DAILY NEWS, the Communist newspaper MASS LINE and PEKING REVIEW were prevented from reaching the comrades by the prison authorities. Comrade Susan was also subjected to an enquiry by the fascist immigration department. They plan to i mmigration department. deport her for her anti-imperialist po-

litical activity. After three months of harrassment, attacks and vicious slanders against the comrades, the courts called them up without notice to enter a "stay of proceedings" on charges that had already been reduced twice (the first charge of "defamatory libel" was reduced to "publishing libel known to be false", then the second charge was reduced to "publishing libel because the original charge was "hard to prove"). The courts thus openly admitted that the comrades were being persecuted for spreading the truth a mongst the people, and went so far as to attempt to try them for this!

Having exposed themselves utterly, the courts could go no further in their desperate attempts. Under the pretext of "unwarranted expense" they tried to drop the entire proceedings. At the same time, they leave the charges open so that they can be pursued at any future date. After having tried this shameless maneuver, the Supreme Court Judge scampered from the court like a scared rabbit as the comrades directed a withering denunciation against the court. Justifiably enraged, Fred Herzog declared, "We have been in prison for three months on phon-

ey charges. This is typical fascist just-ice!" The RCMP moved in to silence the

four comrades and attempted to forcibly remove them from the courtroom. A fierce battle broke out between the four communist revolutionaries on the one hand and the RCMP and city police on the other. Fighting erupted in the courtroom and in the halls of the court building. It took a large number of police to attack them, to handcuff them and hold them under

threats of "assault charges". The comrades were later released. This shows the terror of the Canadian compradore bour geoisie. They have tried every trick to try to stop the development of the antiimperialist movement in Edmonton, but each trick only further exposes them to the broad masses. In order to try to escape their future punishment at the hands of the people, they have released the comrades without daring to pursue their fascist "trial". As Comrade Fred Herzog said, quoting from Chairman Mao:

"Lifting a rock only to drop it on ene's own feet" is a Chinese folk say-ing to describe the behaviour of certain fools. The reactionaries in all countries are fools of this kind. In the final analysis their persecution of the revolutionary people only serves to accelerate the people's revo-lutions on a broader and more intense Did not the persecution of the revolutionary people by the Tsar of Russia and by Chiang Kai-shek perform this function in the great Russian and Chinese revolutions?"

THE recent development of the Middle East situation has aroused the close attention and concern of the Chinese people and the people of the whole world. On September 17, 1970, U.S. imperialism instigated

the reactionary military government of the Kingdom of Jordan flagrantly to dispatch large numbers of troops to launch frenzied attacks unprecedented in scale against the Palestinian guerrillas in a wild attempt to wipe out the revolutionary armed forces of the Palestinian people at one stroke. In these circum the Palestinian guerrillas rose valiantly to fight back in self-defence. At present, the Palestinian guerrillas are heroically fighting a bloody battle. LACHINE CDDP ISSUES STERN WARNING

Called on to the campus of Sir George Williams University to arrest a student. Harold Glick. for selling People's Canada Daily News, the Montreal Police were severely denounced by the students present. They had to flee empty-handed. The incident oc-curred in the cafeteria where the assistant Dean of Students brought three "security guards" and two uniformed police to stop the spread of revolutionary ideas. In front of 200 students Harold resisted this attack and pointed out that the administration was using the just struggle of the February 11th ents to impose a dark rule of "law and order" onto the student body.

"Smashing arbitrary rules and regulations is the main trend George today", Harold declared, "In two years of struggle the Sir George students have made a contribution to the Quebec people's struggles and the day is not far off when arbitrary rules and regulations will be eliminated by the students themselves."

The People's Democratic Rights Comstatement notifying the citizens of Lachine that the anti-people bureaucrats at City Hall are conspiring to close down Progressive Books and Periodicals on 6th Avenue. On September 15, two clerks from the city administrat-ion came to announce that it was "illegal" to display portraits of Chairman Mao and Comrade Stalin outside the store. When confronted as to what law this was, the two managed only to utter that the "city would pass one." Soon after the Fire Commissioner arrived to "inspect" for "fire hazard". "Had we known that you were selling these kind of books (which serve the interests of the working class)," he said, "we wouldn't have given you a license." The leaflet points out that there are other bookstores in Lachine which distribute the ideology of the bourgeoisie and that these stores are rarely harassed by the Police. In a warning to reactionaries, the leaflet ends,"Any attempt to trample on the democratic rights of the working people of Lachine will be met with stiff resistance. Comrade Cruise was accompanied in court today by his close comrade, Tom Bates, who time and time again rose to denounce the court for its atrocity. "We refuse to participate in these hearings, this court refuses to seek truth from facts, concocts facts to camouflage truth." When he denounced judge Morrison as a fascist running dog, he was dragged, still struggling, out of the court.

A witness at today's trial noted many irregularities, including the fact that the prosecution witnesses contrary to bourgeois law, were allowed to congregate together and concoct their testimony. This same witness reported the judge as saying in a previous trial "I do not intend to be gratuitiously insulted every Thursday just because the police refuse to go ahead with this trial." The judge ordered the press that it could report the proceedings, but none of the so-called "evidence" of two lumpens who were seen participating in the attack on the bookstore. The reactionaries were caught in their own lies. The charge of possession of an offensive weapon must prove the comrades we re not on bookstore property. This they could not show at all; they could only slander the "commie book store", as the crown prosecutor said, for its faithful service to the people of Hamilton.

## PEOPLE'S WAR!

#### The Cambodian People Are Sure to Win Their War Against U.S. Agaression and for **National Salvation**

Hanoi, September 25 (Hsinhua) -

The Cambodian people and National Liberation Armed Forces in their valiant fight against the U.S. and Saigon puppet aggressor troops and the reactionary Lon Nol troops, wiped out or disbanded nearly 110,000 enemy men from March September 18, 1970 including over 38,000 U.S. and Saigon puppet aggressor troops, thus making splendid military exploits, according to the Viet Nam News Agency quoting a report of the News Agency of Kampuchea.

The report said that following the March 18 coup d'état instigated by U.S. imperialism and the usurpation of power by the U.S. lackey - the Lon Nol-Sirik Matak Clique, U.S. imperialism dispatched U.S. and Saigon troops to invade Cambodia on a large scale, scheming to put out the revolutionary movement of the Khmer people and to sabotage Head of State Samdech Norodom Sihanouk's policy of peace and neutrality in a vain attempt to reduce the country into a U.S. military base and a new-type colony. Contrary to the aggressive designs of U.S. imperialism, however, the revolutionary forces of the Cambodian people. instead of being put out, have rapidly developed in all fields, and Cambodia's ter-ritory, instead of being reduced to a mibase and colony, has become a fortified stronghold to annihilate the U.S.

The report said that the Cambodian people with a tradition of dauntlessness have developed their revolutionary cause to a new phase by unanimously responding to the call of Head of State Samdech Norodom Sihanouk to rise to fight against U.S. aggression and for national salvation, closely uniting under the militant banner of the National United Front of Kampuchea and the Royal Government of National Union and waging all-round resistance war of the entire people. In the six months of fierce struggle

against the enemy, the report said, the Cambodian people and the National Liperation Armed Forces have held the initiative of action on all battlefields and put out of action nearly 110,000 enemy troops including over 38,000 U.S. and Saigon ouppet troops, wiped out, mauled or dispanded nearly 100 enemy battalions including three brigades and two multibattalion units and captured or destroyed tens of thousands of tons of weapons and other military equipment. The Cambodian National Liberation Armed Forces

have inflicted an important set-back on the U.S. imperialists, forcing the U.S. combat troops to pull out of Cambodia and driving the Saigon and the Lon Nol puppet troops into great passiveness. Almost all the enemy's strategic communication lines from Phnom Penh to various localities have been cut off by the Cambodian National Liberation Armed Forces. At present, Phnom Penh is encircled and isolated by the Camboo people and the National Liberation Armed Forces.

The report said that in the past six months the people and the National Liberation Armed Forces of Cambodia have successfully liberated vast areas of strategic importance covering more than two-thirds of Cambodia's territory including Kratie, Mondolkiri, Ratanakiri. Stung Treng and Preah Vihear Proes and many towns with nearly three million inhabitants. People's political power at various levels has been set up in many places and is leading the people in the fight against U.S. aggression and for National Salvation. This proves that the U.S. imperialists can not save the reactionary Lon Nol-Sirik Matak Clique from final collapse by bombs, bayonets and dollars.

Sustaining bitter setbacks, the report said, Nixon had to declare troopwithdrawal from Cambodia, but he re-mains stubborn and perfidious, leaving tens of thousands of Saigon puppet troops in Cambodia for permanent occupation of the country in a vain attempt to bols-ter the morale of the Lon Nol Clique. At the came time he ordered extremely barbarous air raids on Cambodia's territory as a direct support to the Saigon and Lon Nol troops. However, all these moves of the enemy have been foiled by the people and the National Liberation Armed Forces of Cambodia.

In spite of fierce air raids by the enemy and bad weather since July this year the people and the National Liberation Armed Forces of Cambodia, firmly holding their initiative of action on all battlefields, have launched repeated at-tacks on the Saigon and Lon Nol puppet troops, winning many important succes-


