Workers League Political Committee Statement

The Federal Government has declared that it is prepared to spend \$40 million to protect the ring of FBI agents working inside the Socialist Workers Party.

U.S. Attorney Robert Fiske Jr. told a federal appeals court last week that the Government would rather concede a legal suit filed by lawyers of the SWP and pay damages than hand over the files of 18 FBI agents working inside that organization.

Fiske stated that the names of more than 100 agents appear in the files of the 18 FBI informers.

"We would rather lose the case than turn over the files of these informants," Fiske asserted before the

three-judge panel of the appeals court which is reviewing the contempt of court citation issued against Attorney General Griffin Bell for defying a legal order to release the 18 files last summer.

Fiske declared that the exposure of FBI agents working inside the SWP would cause "incalculable harm to the nation's ability to protect itself."

Fiske revealed that the Government had already made a "very reasonable proposal" to accept liability for any damages that the Socialist Workers Party could prove they had suffered in the loss of members and revenues, but that Judge Griesa, who issued the contempt order against Bell, had rejected the proposal as "unworkable.

The offer made by the Government is without precedent in the legal history of the American judiciary, not to mention the annals of the revolutionary socialist movement.

The American ruling class has never handed over a dime, let alone \$40 million, to a working class organization which posed a threat to capitalism.

The U.S. Government regularly excludes foreigners from entering this country even as tourists if it obtains evidence that they may have belonged to a communist organization



as long as 40 years ago. But this very Government has now publicly declared that it is prepared to hand over millions of dollars to the SWP, which claims to be Trotskyist, in order to maintain the secrecy of its informers inside that organization.

There is only one explanation for the Government's decision: the FBI agents who are being protected have successfully penetrated the leadership of the Socialist Workers Party and are in effective control of this organization.

The Government's allout defense of its informers indisputably confirms the evidence compiled by the International Committee of the Fourth International proving that the most important of the FBI agents inside the SWP is Joseph Hansen, the chief header of this spy-infested party.

Since August 1977, the International Committee has been publishing evidence establishing that Hansen has been working for the FBI as an informer inside the Trotskyist movement since 1940.

Official State Department and FBI archives obtained by the International Committee through the Freedom of Information Act prove that Hansen's recruitment as an agent was personally supervised by the late director of the FBI, J. Edgar Hoover.

It was Hoover who arranged Hansen's meeting with the FBI director in New York City, B.E. Sackett, after Hansen requested that he be placed in touch with a Government official "to whom confidential information could be imparted with impunity.

Hoover was anxious to recruit Hansen into the service of the FBI not only because he had worked in Mexico as a secretary to Leon Trotsky, but also, and more importantly, because information obtained by the FBI indicated that Hansen had, in fact, been in association with the Soviet secret police prior to Trotsky's assassination.

Documents recently obtained by the International Committee (and published on September 29, 1978) directly implicate Hansen in the conspiracy to assassinate the Bolshevik leader.

Documents also show that Hansen has been the leader of a high-level intelligence-gathering operation working within the SWP that supplies information and advice to both the FBI and the CIA.

The fact that the Government would even consider conceding the case to the SWP proves that what is at stake is the preservation of the most important network of political police presently operating on behalf of imperialism.

All the actions taken by the Carter administration since June establish that Hansen is considered an indispensable operative whose exposure would cause "incalculable

harm to the nation's ability to protect itself."

At a top-secret conference Camp David last June, Attorney General Griffin Bell was instructed by President Carter to defy a court order that he turn over the files of the 18 informers.

At its recent educational conference in Oberlin, the SWP admitted that it had been involved in negotiations with Government lawyers to discuss settling the case with

money. Now the Government is prepared to pay whatever financial damages are asssed by the courts rather than hand over the files.

The official reason being given by the Government for its actions - that the recruitment of informers would be made more difficult if the 18 files were given to SWP - is ludicrous.

Why should the Government be less concerned about the fate of its Attorney General, who it is willing to consign to prison if necessary, than a group of informers?

The decision to save Hansen and the network of his coagents which controls the Socialist Workers Party is the desperate response of U.S. imperialism to the enormous intensification of the world economic and political crisis over the last six months.

Faced with an impending economic collapse and the outbreak of a devastating social crisis in the United States, combined with the enormous upsurge of revolutionary struggles internationally, as shown most recently in Iran, the Carter administration has concluded that the greatest threat facing imperialism is the growing power and influence of the world Trotskyist movement.

The sole representative of Trotskyism today is the International Committee of the Fourth International, which is supported politically in the United States by the Workers League (though it is barred from membership by the reactionary Voorhis Act).

Jones refused to comment on the Cuban spy flights, or on reports about U.S. plans for military intervention in Iran, saying "We don't discuss contingency plans.

But he did say that the military "wants more influence" in Carter administration policy, and that "we've got a lot of economic interests overseas to protect.

The choice of this open imperialistic language is quite deliberate, as the Carter government prepares for desperate military actions against the revolutionary movements of workers and peasants in Iran, southern Africa, the Middle East, and Nicaragua.

Even more ominous is the buildup of weapons of mass destruction and the forces of NATO aimed against the Soviet Union and the workers' states of Eastern Europe

Carter's new budget will nelude a three percent increase in real military spending (a ten percent increase before inflation) while spending on social services will be slashed by \$15 billion

This huge military buildup is a necessary outcome of the world-wide capitalist economic 'crisis. Regardless of the pleas of Stalinists, reformists and pacifists of all description, the capitalist class knows no way out of the contra-dictions of its own system except through the launching of new wars of imperialist aggression.

The only answer to the threat of war and the threat to workers' democratic rights, is for the labor movement to go on the political offensive against the Carter adminis-

This means smashing the political alliance between the labor bureaucrats and Carter through calling a Congress of Labor, breaking with the Democratic Party, and establishing a Labor Party to fight for socialist policies

The International Committee and the Workers League have fought relentlessly to expose Hansen and the network of agents whom the ruling class frankly admit are of "incalculable" importance to the defense of imperialism.

Since the ruling class will stop at nothing to protect whatever it considers to be of "incalculable" importance to its survival, it is absolutely clear that U.S. imperialism will go to whatever lengths necessary to stop the International Committee from exposing Hansen and smashing the FBI outpost he has built up inside the international socialist movement.

The money which the Government is willing to pay represents nothing less than a \$40 million contract against the International Committee, the Workers League and

If the Government should ever wind up paving damages to the SWP, it will be entered in the official account ledgers not as a legal expense for 'damages" but rather as a disbursement of funds from one FBI bank account into another.

Hansen is receiving this unprecedented backing from the Government because of his undisputed position as the number one agent of the counter-revolution. If he has any challengers to this title at all, it comes from Ramon Mercader, the assassin of

Trotsky and Hansen's excolleague, whose whereabouts

The specific purpose of the backing now being given to Hansen is to assist him in the organization of a new violent provocation against the International Committee and the Workers League.

The assassination of Tom Henehan, a Political Committee member of the Workers League, on October 16, 1977, just two months after the International Committee initially exposed Hansen's links to the FBI, is an explicit warning of the attacks that are

now being prepared.
The SWP never reported, let alone condemned, the murder of Tom Henehan. This silence, dictated by Hansen and the agents who control the SWP, was tantamount to an open statement of support for the killing.

In the 13 months that have passed since this brutal assassination, the police have made no arrests. Since October 16, 1977, the police out no gation at all into this political killing, which took place in Brooklyn, New York.

The refusal of the police to investigate Comrade Henehan's assassination becomes particularly ominous in light of a new develop-

The WRP has been ordered by a British High Court to pay \$140,000 in damages following a three-week trial which heard a libel suit against "The Observer," a London newspaper.

The jury found that an "Observer" article slandering the WRP as "violent" and alleging that "arms caches" were hidden on the grounds of the WRP's educational center was "substantially untrue," and that the six WRP plaintiffs had been defamed. Documents produced at the trial proved that "The Observer" knew its allegations were false. The allegations were the basis for a massive police raid on the educational center on the night of September 27,

In other words, the WRP proved its case, but it has to pay the costs!

Hansen orchestrated such a campaign in the months leading up to the assassina-tion of Tom Henehan.

The Workers League is absolutely confident that it can meet these dangers and overcome them.

We shall strengthen the security of our movement and campaign for our policies among ever-broader layers of workers and youth.

We shall press ahead for a full investigation into the sassination Henehan.

Finally, the Workers League will indefatigably support the struggle of the International Committee to expose Hansen and his co-agents within the SWP before a rapidly growing international audience of workers, students, intellectuals and youth who are carefully following the results of our investigation into the FBI spy ring inside the SWP.
