DECLARATION AND PLATFORM OF THE BOLSHEVIK FACTION

(All comments in paranthesis are mine (PC) and not part of the document.) When quotes are used it is a translation not a summary.

At the July 1978 BT meeting we became a faction because -

"We have taken this grave step in consideration that since the constitution of the Bolshevik tendency up to to day the crises of leadership in the Fourth International has become generalized. It now touches all areas - theoretical, political, organizational and moral - and it has reached such a degree that it threatens to submit to postration the section and sympathizing groups that follow the orientation of the actual majority of the United Secretariat."

The crises begins in 1969

FLT crises over Portugal and Angola

FLT dissolved to hide political crises and to safe its prestige and to avoid a balance sheet of the tenth world congress.

New leadership an organizational unity "without analysis, nor politics, whose only common point was the struggle against the BT and the plan to maintain the leadership."

CHAPTER ONE "The Reality of our International led by the Bloc without Principles."

BF said all sections and groups led by U Sec. will go from bad to worse. Now to see who was right. Mandel said we have grown ten times.

Lets take the four model examples of the Bloc without Principles (BW). PSR Colombia, LCR France, LCR Spain and PRT Mexico.

Every one in a terrible crises of leadership, finances, press and run by concensus.

France: Daily rouge disaster (because it failed-does not oppose ICR having a daily although he has a passing comment that some will try to explain it wway by saying it was a tactical mistake).

Membership 1850 - terrible. For 3 congresses ICR passed not one political document nor was able to elect a leadership - they elected 20,20,9,1 CC members of tendencies no one a majority.

LCR vote only 73,979 terrible - Rouge tries to lie about vote - never presents it.

Election policy leaves out PC,PS question.

LCR bends to imperialism. (once again the number of articles in Rouge on Africa).

Moreno warned in 1973.

Immigrant workers no attention,

Quotes the Unternational Commission of the LCR to the effect that the LCR has no international work. Nothing was done to protest Frnech armed internvention in Africa.

Leadership functions as a concensus.

Quotes Bourgueil criticizing LCR-

Members don't function. Quotes a Reahud Baying only one siEth in Seine-Denis participated in election campaign.

Quotes Balance of Political Bureau saying organization not functioning well and little workers work.

Quotes a group of comrades saying women are quitting.

Then summation - closing of Rouge, chaos in the leadership, electoral defeat, projects not achieved, no workers work, organizational crises, lost of almost all women comrades.

SPAIN: "The crises of the model of models: the Spanish LCR"

In Spain the IMT line led to disaster.

But leaders of IMT and U. Sec. relect our warnings and instead give super optimistic in reports on Spain.

Mandel in Bogota in 1976 Spanish LCR 6,000 members Riel 77 7,000 Hansen and Riel 8,000 Newspaper of the Spanish section 10,000

"Who lies ?""

On 5 of July the CC of the LCR admits they have only 718 members.

That is only 718 paid dues - counting the ones that didn't they have only 2,203.

Then on to paper circulation. Riel said 35,000. Truth the LCR failed to achieve compaign for 5,000 subscriptions.

Only 800 pay dues and can't get more 3,000 subscriptions section in crises.

The quotes a report from the Political Bureau saying things not working out, not functioning well. Long quotes from report.

LCR and LC unify because both in crises.

Elections. failure only got 35,000 votes - "with 10,000 members and \$5,000 papers they obtain only 0.2% of the electorate in the coutny . ."

(No mention is made, of course, of the BF groups line or results in the election campaign - the election of 26 city council members will undoubtedly be due to the unification with BF members.)

Next "The Latin American model of the US: the Mexican PRT"

Hugo Blanco gave report saying PRT M largest L.4. section because PST A only 250 and PRT M 1,000.

(Then the document goes into at length the recent events in Mexico kicked off at the CC meeting of January.)

(The point made is this: PRT M is not campaigning in the elections instead permitting a discussion. The TOI minority should not have been allowed to form nor a congress held for them - this is a menchevique *concept of organization. BF proven correct in Mexico - proposal for workers and socialist pole. No mention is made of errors on CP o campaign for bloc with CP - error not seen as political but organizational for lack of hardness - bolshevik etc. a constant theme in the document.)

(Quite valuable that Moreno chooses to make this an issue since it exposes his concept of party building - the case is quite clear both politically and eganizationally)

PRT M fails to get 65,000 to become party. Differences and errors of last CC root in failure to get signatures, robted in memberiquexconcept of party building.

Lots of debts from provinces for paper -some members only sell when they feel like it or agree with paper.

Finencial campaign only raises 11,360 dollars - after six months only get 11 dollars per member - terrible -

(ortificially Hugo Blancos name keeps respering as a liar) In paranthesis "Poor Hugo Blanco when he was active in Argentine trotskyism he was a serious and objective person."

Quotes Jaramillo - we have to find out how many members we realty have.

Quotes from regions critical mm of general functioning.

Number of members - (Hugo Blanco once again as liar)also Joe Hansen who "consciously lied"

Hugo Blanco again - linghas a class bases.
Ceneral chaos in PRT M

Next "The Colombian PSR, a party in ruins."

Colombia country where two methods can be compared.

Long section how many memvers in PSR- truth 400, claim 1,000. At a demonstration in Bogota PST had 1250 and PSR 250 prigrat we have photographes to proof it. Meeting for Socorro only 71 at start, later 100.

Fund drive goal 6,000 only 1/3 after first moneth.

Leadership crises on BP member quit and 4 CC members - some PSR koined PST. Includes Medina and 20 T.U. leaders.

Will not find PSR at factory gates, HQ always closed. Quotes from region critical of functioning

(Suddenly the document has a personal message for Hugo Blanco which I can't figure out. I think it is a reference to something in Blanco's document about Moreno. The message begins, "Now, lets explain a simple thing to Hugo Blanco . . . "

CHAPTER II The Evil Tenth Congress

BWP does not allow a belance sheet of 10th wc.

Only groups grown - those not corrying out 10th wc line.

Portugal PRT grew from 10 to 120

formation of LTT - Ninth WC SWP and PST A fought together against guerrilist line.

Qyotes from LTF resolutions egainst GW, its extension, construction of party and mean need to change leadership.

Says LTF formed to fight to change leadership.

Quote Joe H. on lack of proleterian base.

Time to say who was wrong and who was right at 10 ws.

Mandels 3 to 6 year prediction for Europe

(Makes a big issue over lack of concrete demands in European resolutions and refers to a document approved by PST A m written at the same time as MA's criticism of the European document which is then quoted but never foot noted, or atleast I don't know what their talking about unless its the Morenazo document.)

Ultraleft orientation - new mass wanguard etc.

Lack of democratic demands.

At 10th WC SWP and IMT refuse PST A proposal for a campaign of in favor of Angola and Mozambique for the withdrawal of portuguese troops.

Portugal first disaster of 10 WC line.

IMT had 200 members after 1 and a half y ears of revolutionary rise still only 200. Reason turned to ultraleftist mileu not masses.

_ IMT attacks SP not gov. as main danger also pro MFL4-MF4 manuevers.

Lack of comprehension over the anti-imperialist united front of the Black African masses and world wide leades both tendencies LTF and IMT m to a wrong position on the Black revolution as a whole.

The crises of the IMT in Spain,

The IMP European document did not mention Spain or Portugal - including them in the famous ultraleft and Vanguardist ten points program.

One group followed ZIMT other SWP both in crises.

Describes ultreleftism of LCR in Spein

SWP and FLT defended the trotskyist program in Spain.

In a Militant editorial of 1476/74 comparison with Russia revolution and Portuguese made.

(Whole point is quotes from Militent referring to growth of workers powers leter to be twisted to imply we said or egreed with embryonic duel power which will be used as though it is the same thing as workers power.)

Chapter III Birth"The Formation of the Bloc without Principles"

SWP changes its position on dual power in Portugal - error of SWP codified in "Key issues" document also Novack's book Democracy and Revolution.

"The abandonment of trotskist politics on the part of the SWP continues to grow and reaches extremely grave level in Angola . . "

SWP sees MPLA-FNLA-UNITA struggle as inter tribal

90% of LTF resisted SWP line - but Spain LC capitulated.

SWP support collepses over Portugel and Angola - forinstance in Portugel and Italy.

Page 6 (50)

"The IEC meeting of Februery 1976"

U.Sec. refuses to let BF have tape recordings of sessions.

IMT line of military support for MPLA wrong but becomes right after South Africa intervenes and other two groups become lined bp with S.A.

Therefore correct to vote for IMT line critically at IEC.

SWP "political crime" not to give military support to MPLA.

Tony Thomas and Ernie Harsh argue over this in London -Thomas accepts SWP made errors, Harsch doesn't - we know we got ∘ letter.

At IEC FLT splits over portugel -(this is developed - bit.)

"We, even, believe that in all situations of revolutionary rise where there do not exist seeds of dual power, the great task of the Trotskyist is to create them."

Germain informed the IEC that the IMT would make a pact with the embryonic BT. We indicated that we would not yet form tendency "because we wanted to see how fee we could develop our agreement on Angola, and if the possibility extated that a European documented could be drafted that was not ultralaft and that would adopt an analysis and metholdology that was Trotkyist."

"Meanwhile we would collaborate with the IMT to over come the crises of the International."

Thats the way it was at the IEC but now people want to forget. Even Honsen soid IMT is PST A getting closer.

IMT sent the group that broke with LTF there European draft for corrections. The IMT acted very fraternally. But we rejected their document.

*D The self-criticism of the IMT on Latin America"

The re-son for the self-criticism was the collapse of their groups in Letin America

The self-critism has no utility because:

- 1. No one left defending line
- 2. Tries to blome notional sections
- 3. Continues ultraleft line in Europe

Quotes to back up claim of three points.

The only correct conclusion of the self-criticsm is

Chopter IV "The first Documents"

In Europe 180 degree change. Hero no longer Che Guevara but now the dissidents in the East European countries not having democracy.

New adaptation.

(So its understandable let me throw in a comment here. Key is this. Eurocommunism etc. reflects massive petty bourgeois liber-1-demo pressures. IMT -d-pts to this. SWP s-mething from student liberal-demo mileu. From this flows explanation of a lot of things - SWP-INT convergence - resolution on Soc. Dem and Pro. Dictotorship etc. - this is import theme of next sections.)

SXFFirst product of the BWP - revisionist resolution.

(Hong on to your hat for now)

This discussion is more important in the history of marxism then:

- 1. Debate between rev. and reformism at turn of century.
- 2. Bottle between II and III international after WwI
- 3. Debate over soc. in one country. 4. Schattman fight of 1940

BF onswered this document in July 1977 in o reolution titled "The Revolutionary Dictatorship of the Proletariat"

(I have never seen this, but I assume it most exist)

(Long section now follows - The resolution D Soc. Dem and Pro. Dict. believes in freedom for counterrevolution-ries -Mark, Lenin and Trotsky etc. do not. - this theme goes on for a While)

Example shouldn't we execute Pinochet, or Somoza, gents of Savak. Yea for Iranian rev. execution of Savak etc.

SDPD document abandons trotskyist concept of USSR -

Only workers parties which are revolutionary can be allowed. We must purge out a sector of the workers and peasants, their aristocracy - can't have the political liberty without limits advocated in U. Sec. resolution. (This phrase-political liberties without limitationaries repeated throughout.)

Doc. doesn't mention imperialism - only twice.

This (no mention of imperialism) is proof of something the PST A has been saying for a long time. That the comrades of the IMT and SWP EXXESCREEDER do not profess understand profoundly "the phenoments"

(had to change typewriters - type writer collapsed)

"the phenomena of importalish and sur incapable of denouncing it sistematically."

Bocause of ignerance of imperialism fail to note two stages - first destruction of imperialism and latic distruction of socialism.

"The lead luti n contrast bourgeois democracy with proletrian democracy and also with the existing deformed workers states. What it never does is to show that the bourgeois democracy of the Western countries is of an imperialist character, part of a world regime, whose liberties for the metrophhitanos stands on the totalitarian and brutal explotation of the colinial and semi-colonial masses, It is democracy for an aristocracy of workers or burgeois, and explotation, totalitarianism and lack of democracy for the colonial slaves. We define this democracy as imperialist, and for being an based on the profits that is taken from the colonial countries."

The quotes the document as saying that in some countries the defeat of capita/ism has not expanded proletrian democracy with China and Vietnam as the examples.

This is an apology for Chiang Kai Shek and US and French imperialist regimes in Vietnam. To say there is more workers democracy in imperialist countries then in workers states is to capitulate totally and absolutely to bourgeois public opinion.

The BF stands behind the fact that the Chinnse and Vietnamese revolutions have expanded workers democracy colossally in relation to the previous bourgeois regimes and we "underline that, in any workers state, there is a million times more democratic rights than in imperialist regimes . . ."

The U Sec. confuses freedom of the press and opinion with class democratic rights such as work, salary and vacation assured, expropriation of paper and buildings from the bourgeoisie.

World definition of dictar rahip - USec says - samething as correst democracy - wrong one is political form, ther class.

"Fullure to fore see and give line for wars between workers states"

"We show that we should defend small workers states from all invasions by those that are stronger."

(BF foresaw wars between workers states)

The doc. abandons concept of rev. party and int rnational, substituting role of soviets - it favors a populist dictatorship not workers - where the whole people intervene.

Wring characterization of eurocommunism and opportunism rollinis.

Topo Rojo - we've got tapes. Mandel hides real position

BWP says euro communism a progressive phenomena we say not so CPs going from servilism of Kremlin to own bourgeoisie nothing progressive in that. It helps consolidate national stallnist parties.

"Opp rtunist Politics"

(getsniahompoliitikalmrasmkutikax

Of nine points proposed by U Sec. only 2 for action rest general and abstrat.

(develops theme that key is to oppose CP8s program of support to auster; ty measures instead of talking about dem cratic rights in Soviet bloc - gives example of LCR in Spain message to CP that fails to menti n Moncloa pact.

Chapter V "A triumphalist analysis and 14 useless Suggestions"

Criticia of political resolution:

1. Euro centric

2. Triumphalist - everything going well
Not true - after Portugal down turn in Europe - rev. center shift
back to colonial world - Iran, Peru, Nicaragua . BF foresaw all.
Key task in advance countries fight austerity measures.

Russia Rev. opened ener of transition to socialism Similarly that wars between workers states opens a very dangerous of regaining of territory lost by imperialism.

World Pol. Res. ignores three negative crises. 1.Leadership 2.level of living of workers 3. wars between workers states. (one means portugal, two austerity and three China-VN-Camb.)

USEC rev. around the corner - dot coherent with proposed talks which wiseless no action proposed.

Slogans of BF for Iran 1, For development of Rex Iranian rev. 2. Trial of counterrevationaries 3. Destruction f bourgeois army 4. Long live armed milicias.

BF proposals - SWP should send money, arms and volunteers to fight in Nicaragua. We should call for FSLN gov. etc.

U.Sec. silent on Nicaragua - IP only article by Amador which is terrible because it not only criticizes the politics of FSLN which is OK but its struggle.

BF slogans for Black Revolution: For an internal nalist political line which recognizes the Black Revolution as a universal afroamerican process. 2. Fr workers and peasant gov. to replace regimes in Angola, Guinea, Bisseau and Mozambique 3. For black Sociaist republic federation which accepts the right to self dt rainati n of tribes within that federation.

Pochabinataronakia The BF doc. Rev. Dic. and Prol. perdicted wars between workers state. XI WC must say who was right.

Not sufficient to rais slogan Federation of socialist Republic for Europe or United XXXXXX Socialist States of the world. Due to present reality leaves out what GF proposes. East Burope Workers States must form federation now and also call for federation of Iberia workers states and reject CCR call for Federation.

Chapter VI

"Against a Centrist International with POUMist Parties"
"For a Trotokyist Int rnational of Bolshevik Parties"

The picture painted of BF false - no real dem. centralism, instead burgaraxian bureaucratic, no right to tendencies, have a mania for finding a class bases to everything, that we stick ourselves into each section with monetary and cadre help, that we oblige members from student back ground to proletrianize, that BF leaders never write inything like Hugo Blanco says except Moreno, Moreno is a caudillo and controls everything.

First on last point. Moreno has written only 10% of documents of PST A, Colombian PST and BF.

(They say W behind differences is same fight of Lenin over org. concept with mecheviques and also against Urbahns and centrists)

(They say BWP believes a minority has the right to set up a tendency and call a congress setting its date any time it wants. The BF believes in regular one year or every two year co ventions with three or six month, respectively, discussion periods - that is when tendencyes or factions may exist)

All BF groups pay dues to the faction but it only helps situations of rise such as Peru and now it could be Iran.

(long discussion over concept of international. SWP for federation - BWP has accepted this - old IMT for centralist but confused national soction with international - PST A always supported basic IMT concept of centralist - quotes from Trotsky on Spain and Germany for sending money and cadres.) (quotes by Barnes on Hansen at memorial meeting proofing federative concept.)

Quality of branches. In SWP memb rs only have to pay dues. "O have the do whatever they please."

Unlike SWP in PST A one has to be active

Expulsion of Blanco a lie. Bornal quit himself.

Our method requires that every error have established who was responsable. We reject that an error exists without it being attributed to somebody.

There are various kinds of parties now in the International. There are the do nothing types - members do nothing - like PRT M. Then there are social democratic like SWP - everyone pays dues on time withing also - this leads to good strong apparatus but 60 to 70% of members do not attend branch meetings \(\theta\) we have exhaustive reports in this respect. The do nothing we call-trotskyist clubsthe best two examples are PRT M and PSR Colombian. Then there are inbetween groups LCR France and Spain - well intentioned but missed.

"Moral crises"

Fraud being prepared for next WC Mindel and Topo Viejo

Unable to answer BF politically **xx** BWP resorting to clander chauvinism and attempts "atentado" "xx against the security of tritshyist militants facilitating police persecution."

Example the U Sec. representative in Peru who "without doubt faculitated the kidnappin of one of our commades putting his life in danger."

Mexico police accusati n (Cristina case, SWP behind it all)
Central America collaborationist of Somoza welcamed - Barnes
ready to accusate the second over Amador.

"The inlfuence of the petty bourgeoisie"

Some one attended YSA convention and a branch meeting in USA and saw nathing mentioned meeting in Came jo came to Argentina and saw violent discussion in 1970 to which he was not accostumed.

Proletarianization - needed to Bolshevize int rnational.

If no fraude by setting a "Codigo" rules (I think) the BF offers to dissolve itself into a tendency and in 6 months discolve completely.

All we ask: One and the same criteria for representation at WC.

(Among things said here is a passing reference to the womens movement, ecology, and peasants as not central to our work as trade union work - only mention of such issues - nuclear power never mentioned.)

Proletrianization for moral reasons - end concensus method of leadership.

IV "For a Proletrianization of the Fourth Int rnational, of its Proceedures and its Moral"

sections under legality that do not produce regular paper cannot be recognized as having more then 200 members after that its 40 per full timer not counting staffers in technical work.

Propose next WC add to statustes and person having connections with police EXEMPT of my kex kind not officially authorized cannot be a member - (What is this mad man up to ? Joe H. ?) (Amador maybe or both.)

(Thats it. Don't blame me thats what it says. I might have left some important political point ut but the balance is not my fault as you will see when you read the whole thing.)
