# Procedure for report-backs to branches:

Resolution from Jones: To implement the decision of the World Congress concerning members of the FI the following procedure should be adopted. The resolution adopted at the World Congress shall be voted in each branch. All those who do not vote FOR cease to be, by resolution of the World Congress, members of the FI and of the IMC. All those branches and members wish have already voted for the resolution sent out by the special leadership meeting, shall be deemed to have complied with the decision of the World Congress vote and need not revote. 13-4-1-1

<u>Manzano resolution:</u> The PC reaffirms the decsion of the SLM to recommend all branches vote on the resolution contained in the circular "Decisions of the Leadership conerning the split in the FI" 11-5-2-1

Strawson resolution: To refer the problem of LCC cdes to the PB 14-0-0-1

Harlow resolution: Branches should be informed that attendance at meetings taking a represent on thes split in the FI, and where the PC motion is being put is mandatory. This means that all reasons for non-attendance should be agreed in advance by by the branch and apologies have to be accepted by vote of the branch. Written votes are acceptable where apologies have been accepted by the branch. Comrades who feel unable to vote without discussion should be given opportunity to be informed and vote at a later stage. It is the responsibility of the branch leadership to ensure this happens as rapidly as possible:

Resolution of the PC
The Political Committee has found the following charges placed against the following comrades:

- 1. That cde Monica:
- a. organised a meeting between cde Moreno and the WSL, outside the framework of the IMG. The aim of the meeting was to organise to destroy the FI.
- b.publically attacked the ING and the FI at neetings of the ICL and the Socialist Labour Group (OCRFI)

These actions are contraty to section 2 of the IMG constitution.

2. That cdes Monica, Sligo and III nave:

a.organised the public distribution of the Bolshevik Faction Information Bulletin No.3 outside the framework of the IMG

Constituted

b have rejected the organisational framework of the ING by making clear through their actions that they only accept the discipline of the Bolshevik Faction. c.attended a Bolhsevik Faction meeting with a conrade outside the FI.

That these actions are contrary to sections 2 and 8 of the IMG constitution. The IMG PC therefore resolves that given the seriousness of these charges that cde Monica, Sligo and IH are expelled from the IMC. 20-0-0-0

# - impolution:

The ING PC considers that an important mistake was made at the World Congress in most electing a member of the LTT loyal to the FI to the IEC. If there was any doubt concerning the status of any particular individual of grouping this could have been resolved by allocating a place on the IEC and filling if following the mosting of LTT members who rejected the split in January. By that time, the status of all cdes would have been clear.

2. The PC urges the IEC to overcome this situation by seating a member of the LTT at IEC meetings with voice, or alternatively for the section to remedy the situation by substituting a number of the LTT for a place of the IEC.
