Dear Comrades,

Socialist Activists and Educational Conference Assessment

As we pointed out in our June 23 letter to the branches on the Socialist Activists and Educational Conference, "there will be certain expenses incurred in arranging for the conference, travel expenses for speakers, maintenance costs at the conference, and others that will have to be absorbed by a minimal fee not covered by the board and room payment. Information will be forthcoming on the amount and type of fee and when it must be paid when we know what the total expenses will amount to ."

The Political Committee discussed this problem at its July 24 meeting and passed the following motion: "To request a voluntary assessment from each branch of \$7.00 per member to help cover the expenses incurred in organizing the Socialist Activists and Educational Conference."

The collection of this voluntary assessment is the responsibility of the branches. The branches should attempt to collect the equivalent of the assessment times the branch membership. For example if a branch has 30 members it should collect \$7.00 times 30 or \$210.00. This will be possible despite the fact that some comrades will not be able to pay a full or partial assessment if those comrades who are able to pay more than \$7.00 do so.

Since all expenses will be payable before or during the conference the branches should collect the assessments as soon as possible in order for the national office to receive them by the first day of the conference.
