To All YSA Members

Dear Comrades,

As the enclosed release explains, Howard Petrick has been discharged from the Army, and the task which remains is to win him an honorable discharge in the civilian courts. It will probably be a period of at least several months before the case is settled, depending on the verdicts reached by the courts in the various stages of appeal.

This means that the Committee to Defend the Rights of Pfc. Howard Petrick must continue to make known the issues in the Petrick case and continue to gain support for a final victory for freedom of speech for GIs.

Howard Petrick will begin a national tour to explain the new stage of his case and to explain the importance of defending the rights of GIs to dissent. The tour schedule for Howard is enclosed. If these dates are impossible for any area, please contact the defense committee immediately. The tour is of necessity very short because school terms end the latter part of May. This unfortunate fact made it impossible to schedule stops for Howard in many places where there are YSA at-large members. Hopefully it will be possible to arrange for Howard to speak in some of these places during the summer.

A major purpose of the tour will be to raise money for the Committee to Defend the Rights of Howard Petrick. The Committee is over \$1,000 in debt, and will have to incur more debts in order to finance Howard's tour and pay for the expenses of continued publicity and the legal appeals. It should be relatively easy to raise money by holding receptions for Howard at the homes of endorsers or by having parties to welcome Howard back to civilization. At all meetings where Howard speaks a collection can be taken to send to the defense committee. The tour quotas listed with the schedule are barely enough to cover the cost of the tour itself. The tour quotas, therefore, should not be seen as a goal for fund-raising but as the minimum.

During this new stage we will want to continue finding new endorsers of the case. This should be easy to do at all the meetings where Howard will be speaking. However, at this stage a priority should be given to raising contributions for the defense committee from endorsers we already have.

Howard's tour topic should be of great interest, given all the recent evidence of an increasing radicalization among American GIs. Local areas should try to set up meetings where endorsers of the Petrick case from the antiwar movement will speak along with Howard on the importance of defending GIs' rights to dissent.

There is reason to believe that the press will be interested in the case. For instance, at the press conference held after the YSA convention, most questions and interest centered on Howard. We should try to approach the local papers, particularly campus papers, to see if they want an interview with Howard.

Locals should again choose someone to take charge of Petrick defense work and to coordinate Howard's tour. Please send to the defense committee the name and address of this person right away.

The defense committee is putting out a printed leaflet, similar to the earlier one, bringing the Petrick case up to date. Locals should send in orders for the number of these leaflets they can use. Also, please check on your supply of the pamphlet "Free Speech for GIs" and endorsement cards. Although this pamphlet is now out of date, it will still be useful in describing what happened to Howard, and can be used along with the new up-to-date leaflet.
