## To All Campaign Directors:

Attached is a "National Ballot Status Calendar" containing dates of filing deadlines, opening dates for petitioning, dates of petitioning mobilizations, and dates of national antiwar actions. Such a calendar is needed for local scheduling of petitioning mobilizations and national coordination of our ballot efforts.

Some of the dates contained in the attached Calendar may be off by a day or two since they were calculated from the legal provisions in the various states and don't take into account what happens when the specified date falls on a weekend. We are presently obtaining official election calendars from each state which will contain the actual dates.

Campaign committees around the country are urged to send in any additional dates they feel should be added to the calendar including especially dates of projected petitioning mobilizations even if only tentative. Later a revised and expanded Calendar will be sent out.
