A recent article by Caroline Lund in April 5th's Militant emphasizes only "the rulers options" in the Watergate situation. It seems to conclude that the people can't play any active part in the immediate crisis of regime' except to realize how crooked Nixon & all politicians are and ultimately start their own labor party "to bring the Watergate gang to justice".

Though we may agree with the ultimate need for an independent party of working people, we don't agree that revolutionaries should merely critique the Watergate crisis and fail to actively intervene now "to bring the Watergate gang to justice" by forcing Nixon's eviction from the White House. There is no question that Nixon's removal would benefit the interests of the majority of working people, but his continued rule would be disastrous if he get's a way with it.

That's why the National Campaign to Impeach Nixon seeks to encourage majority support for Nixon's impeachment now. We agree that the Democratic & Republican parties are manipulating Congress! endless proceedings while Nixon tries to take the offensive publicly. At the unhurried rate Judiciary's investigation is going, it will not meet its promised April 30th "deadline" to report, the House's impeachment vote won't come until summer and a Senate trial (if there is one) wouldn't take place until fall. Nixon's removal from office may seem "inevitable" to some, but we don't think it is "a sure thing" --even if the NYTimes and Wall Street Journal say so. They also told us to lower our militant voices and trust the government to end the war but only mass popular action forced them to get

Consequently, we are currently mobilizing people for mass actions April 27th in Washington, Chicago and Los Angeles to demand an immediate House vote for impeachment and speedy Senate trial. As we see it, the peoples' upsurge after October's Saturday Night Massacre made impeachment a possibility and now only a militant people can make sure it happens. Nixon should and can be ousted, but on our terms, not his and not theirs.

Dear Impeachment Supporters,

The grass roots impeachment work across the country is bearing fruit. The House Judiciary Committee has received 288,853 requests for impeachment and only 42,916 against. Reports from other Congressional offices indicate similar mail—mail in greater volume than on other issues with wide margins of support for impeachment.

Two out of every three Americans want President Nixon's crisis resolved either by resignation or impeachment, according to a public opinion survey by the Roper Organization reported in the February 3 Washington Post. The Gallup Poll reported in the same issue shows that 64% disapprove of the way Mr. Nixon is handling his job and an all time low of 26% approve. The American people have lost confidence in the president.

Unfortunately, Congress is very slow to move. We cannot assume that the House Committee on the Judiciary will bring forth an impeachment resolution without continued public pressure for it. Grass roots pressure must continue, and national action is needed to focus on the peoples' demands for impeachment.

Grass roots organizers will have an opportunity to come together from all over the country at the NATIONAL IMPEACHMENT CONFERENCE to be held March 1-3, 1974, in Chicago, Illinois. The conference will offer an opportunity to compare local work, to evaluate recent events such as the National Lobby-In of February 4-8, and to plan a program of activities for spring and beyond. The three day conference will begin with registration Friday afternoon and evening at Liberty Hall, 2440 N. Lincoln, Chicago, Illinois.

We urge all impeachment organizations and organizations working for impeachment to send two representatives, one female and one male. To ensure fairness, each group will be allocated two votes, but organizations may send additional observers. Since the conference must develop a future national program, we are urging member groups to formulate proposals before coming to the conference. Program proposals should be written, and several hundred copies should be reproduced by you for distribution at the conference. Many groups have indicated their desire to participate in the proposed national demonstration. Delegates should discuss the demonstration within their organization and come to the conference prepared to make commitments.

A national report by Ted Glick and Kitty Tucker, National Campaign co-ordinators, and Brian Coyle, impeachment organizer for New American Movement, will open Friday evening's session. The report will be followed by discussion of the proposed spring demonstration and introduction of other proposals for our 1974 program. Program discussion will be taken up in regional meetings Sa urday, but it would be helpful to reach a decision about the spring demonstration Friday night so that appropriate planning to all be done at the Saturday regional meetings.

tion and planning at Liberty Hall and Wellington Church, 615 Wellington, Saturday afternoon will begin with a panel discussion of immediate questions facing us, such as:

What if congress doesn't move?
What if Nixon quits before a vote?
What do we say about Ford?
What do we say about new elections?
How do we relate to '74 elections?
How can the energy crisis, and other important, issues be related to impeachment?

The panel discussion will be followed by a brief talk on "Beyond Impeachment" with group discussion and questions following. The afternoon will end with regional workshops to take up the questions raised that afternoon.

Sunday, regional groups will report back to the full session. The whole body will make final decisions about program, organizational structure, and any possible activities "beyond impeachment." The conference will close with a panel on ways to broaden our coalitions.

Please return the enclosed advance registration form immediately. Spread the word about the conference, and plan to join us March 1. The people have made impeachment a possibility; buly the people can make sure it happens.

# a call to action

We, the People of the United States, are in the midst of a crisis which demands united action. The administration of Richard Nixon has proved itself to be one of the most corrupt and repressive in our nation's history. We, the People must act to recapture the promise and hope upon which we were founded. We must act to regain control over the institutions of which we are a part. We must come together as a free and brave people to save our country from those who, by hook or by crook, would steal even more of it from us. Government of, by and for the corporations has become our lot; we must act, in the words of Abraham Lincoln, so that "government of, by and for the people shall not perish from the face of the earth."



#### The Public on Impeachment by Kitty Tucker

Public support for impeachment has grown over the past months. The continuous revelations of mutilated or missing tapes, questionable presidential tax returns, indictments of Nixon's former top aides, and Republican losses in former Congressional strongholds have contributed to the growing impeachment sentiment. But the work of grass roots coalitions has also been invaluable, and is begining to show a shift toward impeachment in Congress.

The Judiciary Committee has received pro-impeachment mail from 347,786 people as of February 4, compared to 79,018 who were against impeachment. The committee is still receiving so much mail that they are over a month behind in counting it, according to spokesperson Barbara Fletcher of the House Judiciary Committee staff.

Nixon's popularity continues to fall.
"Louis Harris surveys....found a 54-to-32 majority for impeaching him if he with-holds evidence from the House inquiry," according to the March 18 issue of NEWSWEEK. The March 21 WASHINGTON POST reported the most recent Gallup Poll showing only 25% approving the way Mr. N Nixon is handling his duties as President, while the latest Harris Survey showed a 26% positive rating against 71% negative.

Impeachment is still misunderstood by

many Americans, according to the results of a NEWSWEEK survey printed March 25. While 60% of the respondents favored having the Senate hold a trial on whether President Mixon should be removed from office because of charges relating to Watergate, only 43% felt a House vote to impeach the president would help the country.

In order to make the figures match for questions on "impeachment" and questions describing the process, our grass roots educational efforts must be increased. The public outcry after the firing of Special Prosecutor Cox forced the House of Representatives to consider impeachment in the Judiciary Committee.

Now, Republican electoral losses are making bipartisan support for impeachment in the House more likely.

Only constant public pressure will make impeachment a reality. Continued local activities are essential, and mobilization for the April 27th demonstrations is vital if Congress is ever going to move on impeachment. We cannot assume that either impeachment or resignation is inevitable, for Congress has ignored its responsibility to protect the public from executive abuses for a long time. As the ACLU bullatins say, "The only thing that can stop impeachment now is your silence."

The Spring Campaign



The National Impeachment Conference mandated a Spring Impeachment Campaign when they met March 1-3 in Chicago. The Conference urged local groups to continue or initiate the following:

- 1. Establishing home impeachment centers
- 2. Lobbying at local congressional offices
- 3. Doing letter writing campaigns
- 4. Circulating congressional questionnaires
- 5. Circulating petitions to work against Congresspeople who fail to support impeachment
- 6. Supporting independent "impeachment candidates

7. Establishing labor outreach committees

8. Petitioning and leafletting in gas lines.



### Chicago Conference Resolutions

1. Resolved, that the National Office and the local coalitions expand or establish ties with chapters of national organizations that have declared support for impeachment (ADA, NAACP, ACLU, AFL-CIO, UAW, etc.) in order to build a united front.

2. Resolved, that a telephone tree be extablished in all metropolitan locales to create a mass reactive network for future repressive acts (e.g., firings) by the administration. The NCIN would mobilize the phone tree for local demonstrations when Nixon visits their community.

3. Resolved, that it be a major thrust of our organization to make impeachment

an issue of the '74 campaigns.

4. Resolved, that we support the various citizens groups in their studies of legislation concerning "cures" and/or "solutions" to our constitutional crises for the purpose of establishing future lobbying policies (e.g., election law reform, presidential succession, criminal code reforms, special investigations).

5. Re solved, NCIN support all judicial actions to expose repression and sabotage by all government agencies, including not only the Democratic National Committee Watergate suit, but also Ralph Nader's Public Citizen suit, the Common Cause suits on campaign financing, Carl Stern's National Broadcasting Company suit (against the FBI), the Lawsuit to Set Aside the '72 Election and the Socialist Workers Party suit to reveal the "disruptive activities" program.

6. Resolved, the associated impeachment coalitions empower NGIN headquarters staff to issue immediate statements in view of any of the following events; an impeachment vote, a filibuster delaying an impeachment vote, any major resignation or official removal or the declaration of a national emergency. It is further resolved that an emergency meeting (or conference call) shall occur within 5 days of such an event to discuss alteration of Campaign plans. Details of enactment of this resolution are to be handled by the office staff. (CONTINUED PAGE 4)

# Local Activities NATIONWIDE!

NATIONAL LOBBY-IN

A successful National Lobby-in was held February 4-8 in Washington, D. C. Three hundred and fifty citizens from 15 different states visited approximately 70 Congresspeople and two-thirds of the House Judiciary Committee.

Busloads of people arrived from New York City, Connecticut, Delaware, and Philadelphia. The groups rallied in Lafayette Park across from the White House before marching up to the Capitol.

Other citizen lobbyists traveled to the Capitol by thumb, by car, or even on foot. Grey-haired Letti Jenks of Cleveland, Ohio, set off on foot with a sign urging "Impeach King Richard." She walked all the way to Pittsburgh, where snowy mountain weather forced her to use public transportation.

The national office has developed resource contacts and materials, and it will assist any local or campus groups who come to the Nation's Capital for impeachment lobbying. Individuals or groups can help provide information to others by completing our lobby-in follow-up forms after their visits. The office has Congressional Fact Sheets on all Congresspeople. Congressman Coughlin, Pennsylvania; Congressman Rangle, New York, Congressman Drinan, Massachusetts, and Congressman Young, Feorgia spoke to the group during the afternoon impeachment forum.

#### (RESOLUTIONS CONTINUED)

- 7. Resolved, that if impeachment or resignation does not occur before August. I, another national conference will be called for Labor Day, September 2, 1974, in order to plan further political actions during the election campaigns.
- 8. Resolved, that the National Office d develop an organizing manual describing possible impeachment activities, outlining procedures, including sample materials, and citing resource groups.
- 9. Resolved, that the National Office develop a national speakers bureau.
- 10. Resolved, that NCIN endorse independent truckers shut down and seek their



support for impeachment as long as their demands are consistent with NCIN policy.

11. Resolved, that NCIN support a call for new Presidential Elections as part of its support of actions leading to a viable Presidential Succession Act.

#### MAY 4TH AT KENT STATE UNIVERSITY



Warfare continues in Indochina, supported by funds from the United States. The Pentagon has requested to spend \$474 million extra this year in military aid to South Viet Nam. Senate opponents argue that a transfer of funds would nullify the intent of Congress to set a strict ceiling on post-war spending in South Viet Nam.

## MINFY

The Spring Impeachment Campaign was outlined by the Chicago Conference, and financing the program is our next step. The Washington Area Impeachment Coalition voted to donate \$500 to the NATIONAL CAM-PAIGN TO IMPEACH NIXON at their March 18 meeting. We urge other local impeachment coalitions to make contributions to develop materials for the Spring Impeachment Campaign, bring speakers to the rallies, and keep the national office functioning. If your group doesn't have money, you might write letters to five wealthy people in your community requesting financial assistance, or send their names to the Washington office.



In order to maximize our lobbying power, the Chicago conference resolved to create a national telephone tree. To do this effectively, we suggest that you read this article carefully before bringing it up before your group, as the details are important.

#### WHAT IS A TELEPHONE TREE?

A telephone tree is a system designed to communicate rapidly with a large number of people in order to create a mass citizen reaction to pressure government functionaries. The decision to respond to a public event is made by a central board which then activates the tree by calling the base committee of five to ten people. Each member of the committee calls five pre-assigned individuals. These individuals each call five other individuals, and so forth until all of the persons on the group's list have been called. Each person contacted then calls their Congressperson or sends a telegram on the issue at stake. (CON'D PAGE 7)

The record is available at your local record shop, or from the National Campaign to Impeach Nixon. It may prove to be a good item to add to your stock of fundraisers for impeachment.

#### HOW DO WE SET UP A LOCAL TREE?

To simplify the creation of a national tree, we suggest following these steps in your area:

- 1. If you have a mailing list from your impeachment activities, put the names on 3" by 5" cards and organize them into zip code or town groups. Your collected signatures on petitions may provide your initial list. If you have no such list, pull one together by contacting liberalradical groups in you area (Women Strike for Peace, SANE, NAACP, etc.) and working out an agreement to cooperate on setting up a tree around the impeachment issue. Remember: every group is careful about its membership list and will probably not release them to you, so be prepared to set up parallel trees in each group's list.
- 2. When you have your card catalogue set up, look up the phone numbers of the listees, if you don't already have them. This is a drag, and should be spread out among a committee of workers.
- 3. Pick out 5 to 10 very reliable people to form the base committee. The larger the base committee, the more reliable the list. This can be shown by a quickie analysis of the tiers, or levels, of a pair of trees, each with about 1000 members:

Base committee(each call 5)	5	10
First tier(each call 5)	25	50
Second tier(each call 3)	125	250
Third tier(each call 1 or 2)	375	750
Fourth tier(no calls)	500	
TOTAL CALLED	1,030	1,060

In the first case, three tiers were needed to get to the final callers and 530 people were needed on the calling committee. In the second case, only two tiers were necessary to reach the final callers and a calling committee of 310 was involved. The fewer tiers, the less time to activate the entire tree and the fewer people required to make more than the one all important phone call. The members of your base committe should be spread out into various parts of your territory in order to decrease phone costs

to distant points. It is best to choose people who are at home most of the time as they can be reached most easily and also prove most persistent in getting all five calls through.

- 4. Arrange your crew in descending reliability. The people least involved in daily activities should be near or at the bottom, as you do not wish to ask for more than a single call from them. The people on the first and second tiers should be more reliable as their calls are the basis of a true mass action. (If they foul up, the bottom tier never gets the word!)
- 5. Pick out a test name from the bottom tier for each town and arrange to call it at the end of the workday (about 4:30 pm) to check if it has been previously called. This will let you know if your tree's roots are as deep as they should be.
- 6. Now comes the tough part. Once you have gone to all the work of setting up this masterpiece, you must discern if the original calling committee (the first two or three tiers) will cooperate. If someone has signed a petition, if you know them personally, or if they are active in another group, they will probably consent to do the small job of making 5 calls when a crisis erupts. Be persistent in reaching these first tiers when setting up your tree. Oftentimes a differnet me member of the family of the contact you reached may be willing to handle the job (e.g., somebody's resident mother-in-law, grandfather, mate or whoever) and you should ask if such a person is available instead of just going on to the next prospective caller.
- 7. When the tree is finally set up, send each person on the list a phone card (see next page) with the proper numbers to call. (Pre-printed cards, to be placed next to the phone, are available from NC NCIN HQ.) If your total list is over 2000, it will pay to take out a bulk rate permit for this mailing. Apiece costs 6¢ on bulk instead of 10¢, but requires an initial fee of \$40. It will, however, save you money on future mailings.
- 8. You can pre-print the names and num-

bers or have volunteers neatly print them in the proper spaces. Be sure that you correlate the proper towns to the proper Congressional districts. To get the needed information, call:

\*for district boundaries, League of Women Voters, or Congressperson's office locally, or the town clerk's office.

\*for the D. C. offices, all Congresspeople can be reached through the main switchboard, 202-224-3121.

\*for Congressperson's local office, look under "U.S. Gov't" in the phone book.

\*for Senator's local office, call information in the largest (or capitol) city in your state.

9. When you are set up, send a card to NCIN HQ with numbers for three members of your base committee so that at least one can be contacted at any time. Your base committee members should also have each other's numbers as well as their preassigned numbers.

10. Keep expanding your tree to maximize the punch of our actions.

WHAT SHOULD WE SAY IN THE CALL ITSELF?

Keep the call simple and short. Express your opinion in an unhurried, clear manner. Request that your name and address be taken to emphasize that you are in your Congressperson's district. Ask for an answer to verify that your call was registered with your representative.

WHEN SHOULD WE CALL?

The best time to call is mid to late afternoon (2 to 5 pm, D. C. time) but it is better to call when you can as you may forget later. It is also important to persist if there is a busy signal.

Our power has never been really tightly organized, and this is one way to do it. It gives us the opportunity to involve a large number of people directly in the action, a matter of no small concern in future political activities.



# Dump Nixon protests set for April 27

Mass demonstrations in three cities on April 27 to demand the impeachment of President Nixon were announced last week at a national gathering of pro-impeachment forces in Chicago, III.

The National Impeach Nixon Campaign also called for "hometown actions" during the congressional recess the week of April 15 to 21.

The April 27 demonstrations will be held in Washington, D.C., Chicago and a West Coast city (probably Los Angeles) to be determined later. Coordination and planning will be carried out on a regional level for the demonstrations and some activities are already scheduled.

In Washington, a three-day "lobby-in" will build for the April 27 demonstration. The demonstration itself will begin with a march through the federal triangle area followed by a rally. An impeachment fair where local community and national organizations can set up booths or displays will stress continuation of local work on a local level.

"Impeach Nixon" will be the main demand of the three regional demon-

strations, the conference decided. Other demands will include "Roll back fuel and food prices," "No U.S. aid or fuel to repressive regimes abroad" and "Stop repression—defend democratic rights."

The April 27 date was chosen to focus attention on the upcoming report of the House Judiciary Committee, which is investigating the impeachment of President Nixon.

The conference in Chicago, the second held by the National Campaign to Impeach Nixon, showed a marked expansion of delegates and a broadening of the nature of the campaign. Over 125 delegates attended. Organizational representatives to the conference included members of the American Civil Liberties Union, Emergency Civil Liberties Committee, New American Movement, Peoples Parties, Workers Committees to Throw the Bum Out, Peoples Bicentennial Commission, War Resisters League and over 30 local impeachment groups.

Edith Tiger, of the ECLC told the conference, "We must remember that impeachment is a political process, not a judicial one." Eleven resolutions, including one supporting the recent truckers strike, were passed during the three-day conference.

Meanwhile local actions continue to press for the ouster of President Nixon.

In New York City, when the Republican National Womens Club presented the "Woman of the Year" award to Tricia Nixon March 9 at the Walforf Astoria, some 250 people picketed the event outside.

Another recent Republican party function in Madison, Wis., was picketed by some 35 persons who chanted, "Tax the rich, feed the poor, throw Nixon out the door" and Exxon, Standard, Mobil oil, no more profit from our toil." The protest was sponsored by the Wisconsin Alliance.

A scheduled March 15 appearance by President Nixon at the Conrad Hilton Hotel in Chicago will be picketed by a coalition of forces.

# Oust-Nixon demonstrations mapped in 3 cities April 27

CHICAGO, March 8 — Activists from Impeach-Nixon committees met he weekend and mapped demonstrations in three major cities April 27.

The 150 delegates, who met here three days, planned demonstrations in Washington, Chicago and one West Coast city to be determined later.

The central demand of the demonstrations, which will be preceded by a week-long lobby in Washington, is impeachment. The conference voted also to carry slogans on the energy crisis, as well as calling for a rollback of food and fuel prices and ending the wage freeze.

Of the 150 participants, about 50 were actively involved in grass roots work for Nixon's removal. Their discussion focused on methods of mobilizing people mainly to pressure Congress for an impeachment bill.

Among those present were three organizers of 100 Illinois. "neighborhood impeachment centers."

A political process

"We must remember that impeachment is a political process, not a judicial one," said Edith Tiger, national representative of the Emergency Civil Liberties Committee, who keynoted the conference Friday evening (March 1).

David Fishlow, national field director of the American Civil Liberties Union, added, "It is no accident that the power to impeach the President is placed by the Constitution in the hands of that body that must stand for reelection every two years."

Speakers' pleas

Speakers urged linking up President Nixon's Watergate involvement with the crimes of monopoly-big business against the people: the energy crisis, the continued support for the Thieu war effort in Southeast Asia, racist and political repression — the entire crisis in everyday living.

On the final day, however, when decisions were taken, the participants failed to include the crisis of racism in the U.S. at the hands of Nixon and big business. They also narrowly voted not to link the demand for impeachment with the mass demand for new elections.

This reflected the composition of the conference and the lack of participation by delegates from the labor, poor people's, Black, Chicago, Puerto Rican or movements.

There was no consultations before the conference with trade union leaders regarding dates for joint action although the unions are collecting thousands of signatures for impeachment.

A group of about six members of the so-called "Revolutionary Union," an anti-communist Maoist outfit, was able to tip the vote against new elections. This group opposed the impeachment slogan saying that this "sowed illusions" about Congress, and adding that to raise the issue of new elections is to sow illusions about elections.
