## PROPOSED ORGANIZATION OF CONVENTION.

1. Motion: that the following rules govern convention procedure:
A. In cases of procedural disputes, discussion shall be limited to two speakers, one for and one against, and that each speaker be limited to two minutes.

B. Discussion from the floor shall be limited to 10 minutes per speaker.

- C. A speaker may have the floor only once in a given discussion until all those who wish the floor have had the opportunity to speak.
- D. All voting, except for election of National Committee and National Control Commission, will be done by voice vote unless a division of the house is called for; then the vote will be taken by a show of delegates' cards. tion of National Committee and National Control Commission shall take place by secret ballot.

E. Only delegates shall have voice and vote. Fraternal delegates shall have voice and consultative vote.

- F. Alternate delegates have voice and vote only when acting to replace a regularly elected delegate.
- G. In all other cases, Roberts Rules of Order shall apply.
- 2. Motion: that the Presiding Committee be composed of the outgoing Political Committee: Barnes, Breitman, Britton, Camejo, A. Hansen, J. Hansen, Horowitz, Jenness, Jones, Lovell, Morrison, Pulley, Shaw, Sheppard, Stone, Waters, and Political Committee Consultative members: Dobbs, Kerry, and Novack.

    D. Political Resolution: 1½ hour plus ½ hour summary.
    E. World Movement Report: 1½ hour plus ½hour summary.

  - F. Organization Report: 14 hour plus ½ hour summary.
- 5. Motion: that 10 minutes each be granted the 3 appeals.
- 6. Motion: to grant a delegate who supports the Thorstad-Green Amendment an extension of 10 minutes during the discussion of the Political Resolution.
- 7. Motion: that the following time allotment be given to youth reporter: Youth Report: 1 hour plus 14 hour summary.
- 8. Motion: that the following time allotments be given to minority reporters:

- A. Latin America: 1¼ hour plus ½ hour summary.

- E. World Movement Report: 1% hour plus % hour summary.

- 16. Motion: to elect a Nominating Commission of 20 delegates consisting of one delegate from each branch.
- 17. Motion: to seat as fraternal delegates the following: (1) National Committee members, (2) members of the National Control Commission, (3) heads of national departments, (4) members of the youth National Executive Committee, (5) one delegate each selected by the St. Louis and Pittsburgh branch organizing committees, (6) special guests.
- 18. Motion: that the convention be open to party members, youth members and sympathizers vouched for by the branches.
- 19. Motion: that the official convention photographers be M. Baumann and Petrick.
