# MINUTES OF THE SPECIAL CONVENTION OF THE SOCIALIST WORKERS PARTY

Chicago, Illinois, December 26, 27, 28, 1973

# CONVENED, WEDNESDAY, DECEMBER 26, 1973, at 6:40 PM

Convened by Barnes.

Proposal by Barnes for Presiding Committee: That B. David chair the first session.

## 1. ORGANIZATION OF CONVENTION

Following proposals by Jones for the National Committee:

Proposal: That the following rules govern convention procedure:

- 1. In cases of procedural disputes, discussion shall be limited to two speakers, one for and one against, and that each speaker be limited to two minutes.
  - 2. Discussion from the floor shall be limited to 7 minutes per speaker.
  - 3. A speaker may have the floor only once in a given discussion until all those who wish the floor have had the opportunity to speak.
- 4. All voting will be done by voice vote unless a division of the house is called for; then the vote will be taken by a show of delegates' cards.
- 5. Only delegates shall have voice and vote. Fraternal delegates shall have voice and consultative vote.
- 6. Alternate delegates shall have voice and vote only when acting to replace a regularly elected delegate.
- 7. In all other cases, Robert Rules of Order shall apply.

CONVENTION ADJOURNED 1:35 PM

We, the representatives of the IEC majority tendency, protest the underrepresentation of the Internationalist tendency at the present convention of the SWP. Having received 92 votes for our platform they received only 2 delegates—the equivalent of 30 votes. The failure of the convention to correct this situation is contrary to the democratic traditions of our movement and more specifically, in the present context of the International debate, contrary to the interests of a democratic discussion and a threat to the maintenance of the unity of the Fourth International.

In sections where supporters of the IEC majority tendency are the majority we have scrupulously respected the rights of minorities. The practice of the LTF exposes the emptiness of their platform positions to guarantee a democratic debate and preserve the unity of our movement. We will be sure to inform the whole world movement of these actions.
