1. CONTROL COMMISSION REPORT ON INTERNATIONALIST TENDENCY

Matson presented the Control Commission report on Internationalist Tendency matters referred to the Control Commission on June 20th by the National Committee plenum. (See attached.)

Presentation of Control Commission Report by Matson

The full Control Commission met and began its investigation during the recent plenum of the Socialist Workers Party National Committee. Although two members of the Control Commission are not resident in New York and had to leave two days after the plenum, they received a full written draft of the report Saturday morning. After having read this draft, all members of the Control Commission participated in a lengthy conference call on Sunday where additional suggestions and changes were incorporated into the final report you have. Thus, the report and recommendations you have in front of you are the unanimous conclusions of the Control Commission, based on the secret internal documents of the IT. We received 12 documents and internal communications of the IT in all. These alone were sufficient evidence for our conclusions.

But we also received additional illustrative material documenting the IT's application of the separate party perspective discussed and adopted at their national conference. Two of the most important findings of the Control Commission in this area were: 1) The presence of a non-member of either the SWP or YSA at the IT national conference. We don't know how many more non-members were present, if any, but we know there was at least one such person. 2) We found that an IT member in the San Francisco branch attended a closed study class of the Revolutionary Marxist Collective, an opponent organization.

You have the full report of the Control Commission before you. Two of the most important secret IT documents that the report is based on are: 1) the resignation statement by Berta Langston and Bob Langston resigning from the IT, and 2) the IT Newsletter of June 6 which contains a report on the IT national convention. I think all of this material is self-explanatory, so I'll just repeat the recommendations of the Control Commission. There are two recommendations and a special point that we wanted to note.

The recommendations are:

- 1. We recommend that the IT's status as a separate rival party be recognized and that the members of the IT party be informed that this status places them outside the constitutional provisions of membership in the SWP.
- 2. We recommend that supporters of the IMT who are not members of the IT remain members of the SWP as long as they abide by the constitution of the SWP, the organizational principles of the SWP, and the democratic centralist norms of the world Trotskyist movement.

Finally, we note that the evidence clearly establishes the complicity of somemembers of the elected leadership of the FI in the IT's decision to form a rival party. But the jurisdiction of this Control Commission is limited to the SWP, and we do not have the authority to go beyond these limits in obtaining information.
