1. Financial Report: Eric Weinberger reported as follows:

Bills Payable \$ 6,646.81

Loans Payable 4,500.00

Total Debt 11,546.81

Less funds on hand -602.51

CURRENT DEFICIT \$ 10,944.30

Of the above deficit, the bills that must be paid at once come to \$4175. The projected on-going expenses for the next month: \$3800. Conclusion: a minimum of about \$8000 must be raised in the next four weeks in order to survive.

It was pointed out that, since April 15th, the weekly income has been about \$1500, but that this has been just enough to pay on-going expenses for staff, office overhead, etc. Those in attendance made specific pledges to help meet the \$8000 deficit. Jack O'Dell agreed to follow up these pledges.

2. Staff Report: Robert Greenblatt reported that staff had been retained until June 1. In discussions with staff, he found that most are available to stay on if needed and that about half are willing to relocate if the national office is moved.

It was agreed that the national office shall remain open, beginning Monday morning, and that the officers shall meet immediately to act on decisions regarding the staff.

- 3. Structure: After considerable discussion, the following proposal on structure was agreed upon with regard to categories of officers:
 - A. Co-chairmen to be actively in touch with day-to-day activities and decision-making
 - B. Honorary Chairmen -- (possibly a different decignation may be chosen) prestigious individuals who are not expected to be closely involved in activities or decision-making
 - C. National Director
 - D. Project Directors to head up specific projects; these posts could be filled from among the officers or new people.
 - E. National Coordinator

On specific names, it was agreed:

- a. The present Vice-chairmen will be asked to serve as Co-chairmen. The list includes: Rev. Ralph Abernathy, David Dellinger, Edward Keating, Robert Greenblatt, Sidney Peck, Mrs. Dagmar Wilson, Cleveland Robinsen
 - b. Al Evanoff will be added as a Co-chairman.
- d. Sidney Peck will serve as National Coordinator, with the understanding that this may be on a temporary basis because he has to remain in Cleveland and also may not be free in the fall.
 - e. One person from SNCC and one from CORE, to be designated by these organizations, will be added as Co-chairmen.

Discussion of adding other Co-chairmen and the Honorary Chairmen was referred to the present Co-chairmen, with instructions to bring specific proposals to the next Administrative Committee meeting.
