CREDENTIALS REPORT

Total attendance was 1186. 688 of those were YSA members, 318 were not members of the YSA or the SWP. 13 fraternal delegates were elected by YSJP chapters.

Convention attendees came from 36 different states and 5 foreign countries. Top states were: 247 from New York, 183 from Ohio, 92 from California, 85 from Massachusetts, 75 from Illinois, 72 from Michigan, 49 from Minnesota, 47 from Pennsylvania, 46 from Texas, 42 from Georgia, 35 from Colorado, and 33 from Washington, D.C.

Of those attending the convention, 23 were under 15; 132 were 16-18; 354 were 19-21; 389 were 22-25; 172 were 26-30; and 53 were over 30.

Of those attending the convention, 677 (or 60%) were male, and 445 (or 40%) were female. Of the convention delegates, 44% were female and 56% were male.

520 (or 40%) of those attending were students. Of those, 436 were college students; 79 were high school students; and 5 were junior high school students. 41 of those attending were members of student governments. 357 of the attendees hold full-time jobs, of which 128 belong to trade unions.

472 convention participants were members of the Student Mobilization Committee, and 124 also were involved in other antiwar groups; 231 were members of women's liberation or abortion groups; 15 were members of Black organizations; 10 were members of Chicano organizations; 2 were members of Puerto Rican organizations; and 11 were members of gay organizations.

11 different "Join the YSA" meetings were held during the convention. 80 people expressed interest in joining the YSA. 29 joined the YSA at the convention, and 25 said they would join when they returned to their local area. East Lansing and Oxford now have enough members to form locals there.
